**MONTHLY REPORT FOR FEBRUARY 2021:**

Mrs. Sharp updated the Board of Health on the notice of violations the Municipality received regarding the environmental water samples for the Municipal Building. Mrs. Sharp explained Miss Bourdony from Morris County has been assisting the Township. Copies of all water testing reports conducted by Harding Township were forwarded to Miss Bourdony who responded to the NJ Bureau of Safe Drinking Water. Miss Bourdony is awaiting their response.

Miss Brady reported that the immunization audits at the Harding Township School and Deep Roots School have been conducted and both are compliant. The Health Educator updated all COVID-19 educational materials and forwarded a copy to Harding (included in the meeting packet).

A discussion ensued regarding the quarantine requirements. It was suggested that if there are updated requirements, that they be posted on the Township website.

A discussion ensued regarding the opening of the school and if the local Board of Health could assist with this. Mr. Joe Sordillo, BOH Attorney, explained that once the executive orders are lifted, that the local Board of Health could assist.

With no further comments a motion was made to accept the February 2021 Monthly County of Morris report by Mrs. McKittrick, seconded by Mr. Platt, and with a vote of all ayes, none opposed the monthly Morris County report for February 2021 was accepted.
