MINUTES OF OCTOBER 13, 2022:

Dr. Cervone asked if there were any questions with regard to the October 13, 2022, minutes. Upon a motion made by Dr. Lacz, seconded by Mrs. McKittrick, Dr. Kao, Dr. Cervone, and Mrs. DiTosto recused themselves, and with votes of all ayes, none opposed, the minutes for the October 13, 2022, meeting were accepted.

MONTHLY REPORT FOR OCTOBER 2022:

Mr. Byrnes reported on the septic repairs and septic alteration applications for the month of October.

Mrs. Sharp reported that the rabies clinic went well with 66 dogs and 8 cats being vaccinated.

Mrs. Sharp provided an update on the quarterly environmental water samples taken for the Municipal Building. One of the samples tested positive for total coliform. Resampling of three separate locations was taken and one sample returned a positive for total coliform. It was suggested by the water company to take a raw sample at the well. This was done today by Mr. Toribio, DPW Superintendent. Mr. Toribio has scheduled the well to be disinfected for early December. Mrs. Sharp explained the State has sent a letter along with paperwork that will be required to be completed by December 2, 2022, along with the results from the three additional water tests. Mr. Toribio will complete the paperwork and Mrs. Sharp will conduct the follow-up water samples. Mrs. Sharp explained that she

contacted Dr. Perez, Jr., Health Officer regarding the water and he provided someone from his office to assist Mr. Toribio with responding to the State.

With no further comments, Dr. Cervone asked for a motion to accept the October 2022 monthly Health Department report. Upon a motion made by Mrs. DiTosto, seconded by Dr. Kao, and with a vote of all ayes, none opposed, the monthly Health Department report for October 2022 was accepted.
