THURSDAY, FEBRUARY 8, 2024**

Reorganization Meeting Minutes

Secretary Sharp called the reorganization meeting of the Harding Township Board of Health to order on February 8, 2024, at 7:30 p.m., and announced the meeting was called in accordance with the laws of the State of New Jersey.

Secretary Sharp reported that on January 4, 2024, the Township Committee of the Township of Harding held their reorganization meeting and at that time they appointed to the Board of Health; Mrs. Christina McKittrick as a Regular Member, Mrs. Julia Somers as Alternate #1, and Mrs. Lydia Chambers as Alternate #2. Mr. Joseph Sordillo, BOH Attorney administered the Oath of Office for the above BOH members.

ELECTION OF CHAIRMAN AND VICE CHAIRMAN:

Secretary Sharp opened the floor to accept nominations for the office of Chair of the Board of Health for 2024. A motion was made by Mrs. McKittrick, seconded by Dr. Lacz, to nominate Dr. Cervone as Chairman of the Board of Health. Secretary Sharp asked if there were any further nominations for Chair of the Board of Health. With no further nominations, Secretary Sharp asked for a motion to close nominations for Chair. Upon a motion made by Dr. Lacz, seconded by Mrs. McKittrick, and with a vote of all ayes none opposed, nominations for Chair were closed.

Secretary Sharp called for a motion to accept Dr. Cervone as Chair of the Harding Township Board of Health. Upon a motion made by Dr. Lacz, seconded by Mrs. Somers, Dr. Cervone abstained, and with a roll call vote of all ayes, none opposed, Dr. Cervone was appointed Chair of the Board of Health.

Secretary Sharp opened the floor to accept nominations for the office of Vice Chair of the Board of Health for 2023. Dr. Cervone nominated Dr. Lacz and Mrs. McKittrick seconded the motion. Secretary Sharp asked if there were any further nominations for Vice Chair of the Board of Health. With no further nominations, Secretary Sharp asked for a motion to close the nominations for Vice

Chair. Upon a motion made by Dr. Cervone, seconded by Mrs. Somers, and with a vote of all ayes, none opposed, the nominations for Vice Chair were closed.

Secretary Sharp called for a motion to accept Dr. Lacz as Vice Chair of the Board of Health. Upon a motion made by Dr. Cervone, seconded by Mrs. Somers, and with the roll call vote of all ayes, none opposed, Dr. Lacz was appointed Vice Chair of the Board of Health.

Secretary Sharp congratulated Dr. Cervone and Dr. Lacz and turned the meeting over to Dr. Cervone.

REGULAR MEETING MINUTES

RESOLUTION BOH #01-2024 SCHEDULING OF MEETING DATES FOR THE NEXT TWELVE MONTHS:

Dr. Cervone, Chair asked for a motion to accept Resolution BOH #01-2024. Secretary Sharp mentioned that the Board of Health meetings are conducted the second Thursday of every month at 7:30 pm. Upon a motion made by Mrs. Somers, seconded by Dr. Lacz, and with a roll call vote of all ayes, none opposed, Resolution BOH #01-2024 scheduling of the Board of Health meeting dates for the next twelve months was accepted and is attached hereto and made a part of these minutes. A copy of this resolution will be published in the legal newspaper of the Township of Harding.

RESOLUTION BOH #02-2024 DESIGNATION OF NEWSPAPERS AND FIXING THE CHARGES FOR NOTICES OF PUBLIC MEETINGS:

This resolution is required by State law and the Open Public Meetings Act. Public notices will be published in the *Observer Tribune* or the *Daily Record*. The Open Public Meetings Act allows the Board of Health to charge anyone who would like to receive by mail a copy of our meeting agenda, minutes, and other material upon payment of a fee.

Dr. Cervone asked for a motion to accept Resolution BOH #02-2024. Upon a motion duly made by Dr. Lacz, seconded by Mrs. Somers, and with a roll call vote of all ayes, none opposed, Resolution BOH #02-2024, which sets the fee at \$50.00, was accepted. The Resolution is attached hereto and made a part of these minutes.

RESOLUTION BOH #03-2024 RESOLUTION TO APPOINT BOARD OF HEALTH PERSONNEL:

Dr. Cervone, asked if there were any comments with regard to BOH Resolution #03-2024. This resolution re-appoints personnel for the Board of Health so they can act as the administrative authority for the Board and conduct the work of the Board of Health.

Dr. Cervone asked for a motion to accept Resolution BOH #03-2024. Upon a motion duly made by Mrs. McKittrick, seconded by Dr. Lacz, and with a roll call vote of all ayes, none opposed, Resolution BOH #03-2024, was accepted. A copy of this Resolution is attached hereto and made a part of these minutes.

RESOLUTION BOH #04-2024 – RESOLUTION TO APPOINT BOARD OF HEALTH SPECIAL COUNSEL:

Mrs. Sharp explained this resolution reappoints Mr. Joseph Sordillo, Esq., as Counsel to the Board of Health. Mr. Sordillo has provided all the necessary documents for the professional services agreement. Dr. Cervone asked if there were any further comments or questions. With no further comments, Dr. Cervone asked for a motion to accept Resolution BOH #04-2024. Upon a motion made by Dr. Lacz, seconded by Mrs. McKittrick, and with a roll call vote of all ayes, none opposed, Resolution BOH #04-2024 was accepted. A copy of this resolution is attached hereto and made a part of these minutes.

RESOLUTION BOH #05-2024 - RESOLUTION AUTHORIZING THE BOARD OF HEALTH CHAIRMAN TO EXECUTE CERTAIN DOCUMENTS ON BEHALF OF THE BOARD OF HEALTH OF THE TOWNSHIP OF HARDING:

This resolution enables the Chair to execute certain documents on behalf of the Board of Health, such as, Deed Restrictions, Professional Services Agreements, etc. Dr. Cervone, asked if there were any comments with regard to BOH Resolution #05-2024. Upon a motion duly made by Mrs. McKittrick, seconded by Mrs. Somers, and with a roll call vote of all ayes, none opposed, Resolution BOH #05-2024 was accepted. The Resolution is attached hereto and made a part of these minutes.

BOH WAIVER – FRIGERIO, 10 PRIMROSE TRAIL, BLOCK 36, LOT 3

Mr. Sordillo, Board of Health Attorney, conducted the swearing in of Mr. Jeffrey Careaga, of Careaga Engineering, Inc., representing the applicant of 10 Primrose Trail. Mr. Careaga explained to the Board that this is a three-bedroom dwelling which has an existing grinder pump in the basement. Mr. Careaga informed the Board that this is a real estate transaction with a failing system. The soil testing conducted was very good. The proposed system is an Advanced Treatment Eco Filter system and will replace the existing septic tank and septic trenches which will be abandoned. Mr. Careaga explained there are seven (7) waivers that are being requested of the Board as follows:

- 1) Disposal Field to Property Line with Block 36, Lot 1; 25 feet is requested by Harding Township Ordinance, approximately 10 feet is proposed.
- 2) Disposal Field to Property Line with Block 36, Lot 4; 25 feet is required by Harding Township Ordinance, approximately 12 feet is proposed.
- 3) Disposal Field to Property Line at rear of property; 25 feet is required by Harding Township Ordinance and 10 feet is required by NJAD 7:9A; approximately 7 feet is proposed.
- 4) Disposal Field to Occupied Building; 25 feet is required by Harding Township Ordinance and by NJAC 7:9A; approximately 14 feet is proposed.
- 5) Disposal Field to Deck Footings; 10 feet is required by Harding Township Ordinance and 2 feet is proposed.
- 6) Septic Tank to Occupied Building; 10 feet is required by Harding Township Ordinance and NJAC 7:9A and approximately 5 feet is proposed.

- 7) Disposal Field Sizing; proposed disposal field does not meet the 50 percent increase required by local ordinance when a sanitary ejector pump is installed.

Upon a discussion of the above requested waivers, the Board, as a condition of the waiver requested for #5, asked the applicant to install new footings to the same depth of the disposal field. Mr. Careaga agreed to the Board's condition for Waiver # 5. Mr. Careaga informed the Board that this application requires a TWA approval from the NJDEP. The Board of Health consented to the filing of the TWA application and Mr. Sordillo will provide a letter to Miss Meyers for this application. With no further comments, Dr. Cervone asked for a motion to approve the above waivers beings requested. Upon a motion made by Dr. Lacz, seconded by Mrs. McKittrick, and with a roll call vote of all ayes, none opposed, the 7 requested waivers along with the condition for waiver #5 were accepted.

MINUTES OF DECEMBER 14, 2023:

Dr. Cervone asked if there were any questions with regard to the December 14, 2023, minutes. Upon a motion made by Mrs. Somers, seconded by Dr. Lacz, Mrs. McKittrick, Mrs. Chipperson and Mrs. Chambers abstained and with votes of all ayes, none opposed, the minutes for the December 14, 2023, meeting were accepted.

MONTHLY REPORT FOR DECEMBER 2023:

Dr. Cervone asked if there were any questions regarding the monthly Health Department reports for December 2023 and January 2024.

Dr. Cervone asked for a motion to accept the December 2023 and January 2024 monthly Health Department reports and financials. Upon a motion made by Dr. Lacz, seconded by Mrs. McKittrick, and with a vote of all ayes, none opposed, the monthly Health Department reports for December 2023 and January 2024 were accepted.

COUNTY OF MORRIS MONTHLY REPORT OF ACTIVITIES FOR THE TOWNSHIP OF HARDING – DECEMBER 2023 AND JANUARY 2024

Dr. Cervone asked if there were any comments or questions with regard to the Morris County Monthly Reports.

Miss Myers reported that December 2023 was slow and the Health Educator sent weekly flyers pertaining to Bone Health, Cold Weather, Mental Illness, Your Health Matters Newsletter, etc. A discussion ensued regarding placing the some of the flyers in the Thumbnails. Miss Meyers reported that a follow-up inspection was conducted at Café Sabori on December 18, 2023 and they received a satisfactory for their water. They will now report their water requirements to the Health Department on a monthly basis. Miss Meyers reported that an inspection of Classic Café was conducted on January 26, 2024 and a satisfactory rating was issued.

Miss Meyers updated the Board on the NEHA-FDA Retail Flexible Funding Model grant and mentioned she attended the National Association of County and City Health Officials monthly Food Safety virtual workshop.






