

**HARDING TOWNSHIP  
ORDINANCE 04-2025**

**ORDINANCE CREATING CHAPTER 7, SECTION XXXI, "DIRECTOR OF OPERATIONS," ESTABLISHING  
THE DIRECTOR OF OPERATIONS POSITION**

**WHEREAS**, pursuant to N.J.S.A. 40A:63-1, the Township Committee is authorized to carry out the tasks of appointing and creating positions within the Township government to assist in the administration of the Township's duties; and

**WHEREAS**, the Township Committee has determined that to best ensure the smooth operations of the Township, there is required to be established a Director of Operations; and

**WHEREAS**, the Township Committee seeks to establish the position of Director of Operations through this Ordinance; and

**BE IT ORDAINED**, by the Township Committee of the Township of Harding, County of Morris, State of New Jersey, as follows:

**Purpose:** An ordinance to establish Chapter 7, Section XXXI, creating the Director of Operations position.

**SECTION I.** The Municipal Code, Section 7, Section XXXI, "Director of Operations," is hereby created and shall read as follows:

**7-31. DIRECTOR OF OPERATIONS**


The Position of Director of Operations is hereby established in and for the Township of Harding. The Director of Operations shall be appointed by resolution of the Township Committee to hold office at the pleasure of the Township Committee. The compensation of the Director of Operations shall be fixed by resolution of the Township Committee in Accordance with the applicable salary ordinance. The Director of Operations shall perform such duties as may be required by ordinance or resolution or by direction of the Township Committee or Township Administrator.

**SECTION 2.** This ordinance may be renumbered for the purposes of codification.

**SECTION 3.** This ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law.
