August 5, 2021 Minutes

Mr. Dinsmore made a motion to approve the August 5, 2021 minutes. It was seconded by Mr. Wilson. On a voice vote all eligible members were in favor of approving the August minutes.

CONCEPT

Mr. Maselli recused.

Presenting: Mr. Maselli, Architect Mr. Artigiere, Owner

Mr. Artigliere brought a Concept Plan to the HPC for 10 Twin Oaks Lane. 10 Twin Oaks vacant land in the Silver Lake District. The plan is Classic American. There will be an accessory dwelling. He noted the house is 1200 feet off of Sand Spring Lane and 150 ft. off of Twin Oaks Lane. The house will face Twin Oaks.

Mr. Maselli presented the existing conditions of the lot and noted the location of the building envelope.

Mr. Maselli presented the proposed plans for the property.

Mr. dePoortere asked about the effect from streetscape from James Street. He was concerned if there would be removal off trees that would have an impact.

Mr. Maselli noted that the accessory dwelling would be the farthest structure on the lot with little impact to James Street.

There was a discussion about the materials. Mr. Maselli is proposing shingle and stone. The roof will be shingled.

This project will return as an application for the October 7, 2021 meeting.

DISCUSSION

<u>148 Lees Hill-(No representative appeared)</u>

Mr. dePoortere noted a Demolition Delay application that was submitted for 148 Lees Hill and that the applicant was not present for the meeting. He made a note on the record that the clock for the Demolition will not start until they are present before the HPC and that the hearing has not been open.

88 Lees Hill Road Stair Removal

Mr. dePoortere discussed the removal of stairs at 88 Lees Hill Road. He noted that the owner will have to appear before the HPC when they decide to install the new fence.

There was a discussion about budget. No decision was made. The Commission requested information from the Planner before proceeding.
