Michael Hofmann 34 Blue Mill Road. B16/L26 District: Contributing Independent Site Front steps renovation

Presenting: Michael Hofmann, Owner

- Mr. Hofmann presented proposed plans to replace his front stairs and widen the stairs and the front overhang. They are non-conforming.
- There was a discussion about the proposed materials.
- Mr. Maselli appreciated the tie in of the materials to the rest of the house.
- Mr. Maselli would like to see brackets on the overhang.
- The Commission approved the application.

Marisa Marks 74 Dicksons Mill Road, B10/L3 District: Contributing Green Village Rear porch and side addition

The Commission discussed the application without the homeowner.

- Mr. Maselli asked if there was a variance associated with the application.
- Mr. dePoortere noted that a Halsey survey was submitted.
- Mr. dePoortere commented on the roofline.
- Mr. dePoortere questioned the unknown setbacks due to lack of engineering plans.
- Mr. Maselli noted that the porch wraps around and the addition tucks in behind it.
- Mr. Maselli noted additional mass.
- Mr. Maselli noted that the front elevation windows should be consistent. He also noted that the triple window would better suit as a double.
- Mr. dePoortere noted that a report will be issued to the Construction Department.

Charles Kilgore 82 Sand Spring Road, B22/L1 District: Contributing Silver Lake Amendment Board of Adjustment application for rebuild.

Board of Adjustment Application for side and rear porch additions

- Mr. Burke presented proposed plans for a side addition and a rear porch addition.
- Mr. Burke presented photos of existing conditions.
- Mr. Burke presented the proposed plans and site plan for the additions.
- Mr. dePoortere asked about the height of the addition. Mr. Burke noted is was about 20 feet. Mr. Burke's goal was to blend the roof line in and will look at it further before going to the Board of Adjustment.
- Mr. Maselli asked about the copper leader drains and complimented the use of materials so far. Mr. Maselli asked about the foundation.
- Mr. Maselli asked about the proximity to the neighboring property.
