The commission reviewed the application for 10 Twin Oaks Lane in the Silver Lake District. The commission confirmed that the dwelling would be situated off of Sand Spring Lane and have no impact on streetscape.

It was brought to the attention of Mr. Artigliere that the concern regarding development was for streetscape view towards the back property line which does have visibility from James Street uphill through the preserved Frelinghuysen Fields.

The commission met with Mr. and Mrs. Boag and their architect to review the proposed barn/ dwelling alterations In the Loganville district.

It was noted that due to grades, the visible streetscape elevation was limited to the upper floor and the roof which had a proposed metal chimney.

The color of the roof was also important since that was the predominant portion of the building that could be seen from the road.

The structure was approximately 200 feet off the road.

The overall discussion was about simplifying the window and door alterations to the building in the hopes that when the property is reviewed again the alterations would not be too extreme to make it a non-contributing structure. They also stated they would research different mechanical systems hopefully to minimize any chimney impact on the streetscape.

<u>88 Lees Hill Road Fence Installation</u> The Commission reviewed the fence installation and issued a report on its effect on streetscape.
