- Mr. Burke presented proposed plans for an addition and a two car garage.

- Mr. Burke noted that the proposed garage will be located to the rear of the main house.
- The Commission noted that even though the garage is off of the rear of the dwelling it will still have an impact on streetscape.
- The Commission suggested lowering the roofline of the main house addition to align with the existing left side addition.
- Mr. Burke presented plans for a proposed garage with a third roof style; a modified gambrel roof.

- The Commission suggested carriage house like doors on the garage as they will be front street facing doors.
