### **Reorganization Meeting Minutes**

### **OPEN MEETING:**

Secretary Sharp called the reorganization meeting of the Harding Open Space Trust Committee to order on January 8, 2020 at 7:30 p.m., and announced the meeting was called in accordance with the laws of the State of New Jersey. A motion was made by Mr. Jones, seconded by Mrs. Somers, and with a unanimous vote of all ayes, Mr. Weppler was accepted as Vice Chairman of HOST.

### **HOST UPDATES:**

### Masterplan

Mr. Weppler provided a three page summary of comments regarding the Master Plan. The HOST Committee reviewed the document and made the following comments:

- 1. Discussion on stabilizing the stream bank ensued. J. Somers will contact Princeton Hydro to request that they take a look at the Silver Brook downstream and make recommendations on what can be done about the erosion and what funding is available.
- 2. M. Devine commented that land owners need to be informed when anything is going on with their property.
- 3. A discussion regarding a forester ensued. D. Dietz will contact Mike Anderson regarding a Forester.
- 4. A discussion on mowing a path for Dear ensued. It was suggested that one side be completed first.
- 5. T. Jones will speak with Mr. Fox, Township Engineer, to mark the Township's the Township portion of the Wexford Lane property.
- 6. N. Platt commented he spoke with S. Rubin of the Great Swamp Watershed Association regarding bluebird boxes. N. Platt commented he is willing to donate the time and money to maintain the bluebird boxes. M. Devine mentioned that the Land Trust has the bluebird boxes and would donate them to the Township.

It was suggested that Eleana Gables from Heyer Gruel attend HOST's February meeting to discuss the Master Plan. Mrs. Sharp will send an email to McKinley Mertz of Heyer Gruel.
